## **POLICE REPORT**

**PURCELLVILLE, Va. December 10<sup>th</sup>, 2015 —**

12/04/2015 - 11:23a.m. 1000 Blk. E. Main St. **Employee Dispute**

A business called police advising that an employee had been terminated and was acting disorderly. On police arrival, the person had already left. The business owner was advised what procedures to follow to trespass the ex-employee from the business.

Police were called to the scene of a possible domestic situation. A neighbor had heard yelling and shouting and called 911. On police arrival, contact was made with one of the parties involved.
